The establishment of minimum equipment regulations in no way reduces or limits this responsibility. The captain must further insure that all equipment is properly maintained and stowed, and that the crew knows where it is kept and how it is to be used. It is also the sole and exclusive responsibility of the captain to decide whether or not to start or continue any race.

The organizers and /or sponsors bear no responsibility for accidents, damage, or injuries to yachts or their personnel arising from any cause during this race or related activities.

CERTIFICATION AND WAIVER

I hereby certify that I have read the above entitled CAPTAINS RESPONSIBILITY, as well as the equipment requirements in the Eastern L. I. Yachting Assoc.'s (ELIYA's) "General Conditions", that the yacht hereby conforms in all respects and that all required equipment will be on board at all times during the race.

I hereby agree that neither I nor any of my crew shall hold the Breakwater Yacht Club or the ELIYA or any of their officers, directors, trustees or committee members responsible for accidents, damage or injuries during the race or related activities. No crew member will be aboard my boat who has not consented to this waiver in his or her behalf.

Nothing herein shall waive any claim which I or my crew members may have against any officer or member of the Breakwater Yacht Club or the ELIYA acting in his/her individual capacity as a participant in the race as captain or crew member of any yacht competing in this race.

It is suggested that you disclose this certification and waiver to your insurance carrier prior to the race. This certification and wavier applies to the entry which I have completed above.
